Responsibilities:

The Middle School/Upper School Choral Director will report to the Upper School Head and will be responsible for teaching one 5th grade chorus, one 6th grade chorus, one combined 7th and 8th grade chorus and one combined 9th-12 grade chorus. The Choral director will also play an instrumental role in working alongside other colleagues in the department during school musicals (middle, upper, and all-school musicals) and other student performances. In addition to the normal teaching responsibilities, the candidate will also advise a group of 8-12 students, supervise a study hall, serve as faculty advisor to the upper school A Cappella

group(s), lead a middle school A Cappella group, and perform periodic duty assignments (lunch, traffic, detention, etc.). There is also a current search for the next Performing Arts Department Chair, which could potentially be an additional leadership role in the department for qualified candidates.

Qualifications:

Minimum requirement is that the candidate holds a bachelor's degree in music education, with preference given to candidates who hold a Master's degree in music with an emphasis in vocal/choral music. Candidates should demonstrate proficient keyboard skills necessary for rehearsing choruses. Three years or more of teaching experience is preferred, and candidates should have a strong academic background and possess proficient technology skills. Preference will be given to candidates who have experience teaching middle and upper school grades. The candidate should have superb organizational skills, excellent verbal and written communication skills, and the ability to work effectively as a team member. Experience with the Google Suite of Apps is beneficial.
